Kenneth E. Stevenson and Gary R. Habermas

Verdict on the Shroud - Evidence for the Death and Resurrection of Jesus Christ
(Robert Hale)

This 224 page book, published a year ago in the USA, is now available in the UK. It has some attractive colour photographs of the 1978 scientific work, but is not the definitive book of the STURP testing that it tries to appear. In the USA, several of the STURP scientists felt that their work had been misrepresented, and tried to stop the book's publication. In general, the book overstates the scientific case for the Shroud's authenticity, and presents it almost as proof of the Resurrection. Dr McCrone's work receives undeserved short-shrift.

Just published, this 144 page book is a summary of the most recent information on the Shroud, at a very average layman level. The most original feature is data on plant images provided by the book's contributing science editor, John DeSalvo (see paper overleaf).

3) Dorothy Crispino: *'1204: Deadlock or Springboard'* This argues that the Shroud may have remained in Constantinople after the Crusader sack of 1204.

The Image Formation Process of the Shroud of Turin and its Similarities to Volckringer Patterns

This paper deals with a new hypothesis concerning the formation of the body image: that lactic acid in the perspiration of the Man in the Shroud was responsible for causing cellulose degradation in the linen - similar to the imprints left by leaves pressed in books and left undisturbed for many years (Volckringer Patterns).
